A simple link to your website is not sufficient.

The Paragon Gallery will select 2 Guest Artists for each seasonal time slot.

Wall space is approximately 6' x 4' 6". Floor space has 3 shelves 46" w x 12" deep x 13" high.

- All art must be **original** and presentable for gallery showing. Submissions should be discussed in advance with the gallery representative who will assist you with display and hanging.
- An inventory sheet must be filled out to keep track of sales. Each item must have a small sticker with your initials, an inventory ID# and the retail price. The Paragon receives 30% and the artist receives 70% of the retail price for each sale. Payment is every other week. You are responsible for reporting your income for tax purposes. The gallery is responsible for collecting and paying the sales tax.
- Shipping: If a customer wants an item shipped, unless otherwise marked by you, we add 30% of the sale price to cover shipping (of which you receive 100%) You are responsible for packing and shipping the item within one week of the sale.
- If you move or change your phone number, please update your application accordingly.
- The Paragon is not responsible for theft, damage or any "acts of God" that may affect your artwork.
